NOTICE is hereby given that pursuant to Sections 30 and 31 of the Public Audit (Wales) Act 2004 and Section 12 of the Accounts and Audit Regulations (Wales) 2014 (as amended):

1. From 14th May 2018 to 11th June 2018 (inclusive) between 8.30am to 5.00pm (Monday to Thursday) and 8.30am to 4.30pm (Friday) any local elector on application to the Resources Directorate, Civic Centre, Pontypool may inspect and make copies of the accounts of the above named bodies for the year ended 31st March 2018 and all books, deeds, contracts, bills, vouchers and receipts relating thereto.
2. On or after the 12th June 2018, until the completion of the audit, a member of the Auditor General's team, for and on behalf of the Auditor General for Wales, will, at the request of any local government elector of the area to which the accounts relate, give the elector, or his/her representative, an opportunity to question him about the accounts. Any such elector, or his/her representative, may attend before the Auditors to make any objection to any of the accounts.
3. Any objections must be in writing to the Appointed Auditor, Wales Audit Office, 24 Cathedral Road, Cardiff, CF11 9LJ, with a copy to the Chief Executive, Torfaen County Borough Council, Civic Centre, Pontypool, NP4 6YB.
